New Business - Reserve Study Information - Barbara Shaw

Since our community structures are getting older and older, your HOA 2 Board of Directors have been looking into hiring a Reserve Study company to work with us to make sure we have the reserves necessary to cover any construction repairs needed going forward. We have received proposals from several companies, done background checks and selected a company that we feel best fits our needs. The name of the company is PONO. We have made a three-year commitment to them. The cost of this commitment is \$1,230 per year. They will begin inspections of our community after the first of the year. We are excited to get this process started and will keep you updated on what we learn as the inspections begin.
